Dear 2011 Philmont Participant/Parent:

Congratulations! You are signed up to participate in the adventure of a lifetime.

Below is the payment schedule for the Lake Huron Area Council Philmont contingent scheduled for July 17-29, 2011. The total cost of the trip is estimated at **\$1300 per participant**. (Exact fee will be determined in the spring of 2011) This fee covers the following items: Philmont fee, Amtrak fee, Bus to and from Philmont, Meals to and from on the train, Training fees, One T-shirt, a contingency fee, and an administrative fee. Participants will need a pair of strong lightweight hiking boots to start with. Participants should begin a conditioning program (hiking, running, swimming etc.) wearing the hiking boots as much as possible to "break them in".

The following payment schedule will help us meet our payment deadlines for Philmont.

July 1, 2010:	\$100 Due for a total of \$400 paid (Non-refundable but transferable)
August 1, 2010:	\$100 Due for a total of \$500 paid (Non-refundable but transferable)
September 1, 2010:	\$100 Due for a total of \$600 paid (Non-refundable but transferable)
October 1, 2010:	\$100 Due for a total of \$700 paid (Non-refundable but transferable)
November 1, 2010:	\$100 Due for a total of \$800 paid (Non-refundable but transferable)
December 1, 2010:	\$100 Due for a total of \$900 paid (Non-refundable but transferable)
January 1, 2011:	\$100 Due for a total of \$1000 paid (Non-refundable but transferable)
February 1, 2011	\$100 Due for a total of 1100 paid (Non-refundable but transferable)
March 1, 2011	\$100 Due for a total of \$1200 paid (Non-refundable but transferable)
April 1, 2011	\$ Final payment Due for a total of \$1300 paid (Non-refundable but transferable)
